

# 2019-2020 School Improvement Plan Final Report

\*\*There are several data points that will remain progress monitoring data, as state testing, evaluations and other measures were suspended Spring 2020.


## Academic Goals:

- 1. Raise current Lexile scores to upper 70% range, raise RI Lexile scores by 30 growth points from the fall to spring assessments, and focus intently on our underrepresented student demographics, including Minority, Low SES & FRL, ELL, and Special Education.
- 2. Maintain at least 30% of our student body meeting all four college readiness benchmarks on the ACT exam. This ties directly into students having more success in college (enrollment, persistence, and completion rates).
- 3. Maintain at least a 90% graduation rate with all students. We will be evaluating progress and growth with our underrepresented demographics of students, as well (Special Education, ELL, Minority, and students classified as low income).







Winter - Reading Inventory Across Years by Race/Ethnicity




Winter - Reading Inventory Across Years by Population












### **School Climate Goals:**


- 1. Have at least 75% of Alta faculty demonstrate a 4 to 1 positive to corrective ratio on their CTESS classroom observations.
- 2. Increase the total number of 12<sup>th</sup> grade students of earning the Hawk Engagement Award (Medallion) by 10%.
- 3. Establish the required supports (SST, SST referral, check and connect aide, and additional supports for counseling) to support a fully functioning MTSS. These supports will include funding the Check and Connect Mentors and 1.5 additional FTE for school counselors, as well as continued professional development on the RTI process for all licensed staff.
- 4. Monitor and increase the number of students earning the Advanced and Honors Diplomas and participation in Honors, AP, CE, and Step2TheU university courses. Maintain a 90% graduation rate and the number of Regents' Scholarship qualifiers. Evaluate USHE post-secondary enrollment, persistence, and completion rates to compare against prior years.

# 2020-2021 Teacher and Student Success Plan

Summary Goals on which to Collect Data throughout the School Year

## Academic Goals:

- 1. Raise Reading Inventory scores across all grades levels by at least 7% from fall to spring, particularly focusing on students who begin the school year at below basic level and who are English Language Learners. These students will have the opportunity to further improve their reading abilities through the Read 180 program.
- 2. Maintain at least 30% of our student body meeting all four college readiness benchmarks on the ACT exam.
- 3. Maintain at least 90% graduation rate.
- 4. Expand the Step2TheU program to create a second cohort and give up to an additional 40 students the opportunity to participate.
- 5. Further promote equity by encouraging minority and otherwise underrepresented students to participate in honors, Advanced Placement, Concurrent Enrollment and Step2TheU courses at at least the same rate as their peers.

## School Climate Goals:

- 1. On formal observations, at least 85% of Alta's teachers will demonstrate a 4 to 1 postive to corrective feedback rate.
- 2. On formal observations, at least 70% of Alta's teachers will complete a full feedback loop with at least 2 students.
- 3. Maintain at least 60% of Alta graduates earning either the Honors or Advanced Diploma.
- 4. Maintain at least 20% of Alta graduates meeting the criteria for the Hawk Medallion.
- 5. Sustain a positive culture and climate on inclusivity, mentoring and leardership through an effective MTSS system and by providing for students' growing mental, social and emotional needs. This will result in the maintenance or improvement in the percentage of students who are "At Risk" or "Off Track" according to the Early Warning System indicators.
