



## ALTA STUDENT PARKING REGULATIONS and PARKING CONTRACT

For all employees, students, and visitors who come each day to Alta High School, there are approximately 780 parking spaces on campus. Given the number of people who come each day, the number of vehicles can easily exceed the number of available parking spaces. This shortage is problematic. In order to ensure safe traffic flow and equitable parking for all, it is necessary to regulate on-campus parking. Since parking at Alta High is a privilege – not a right, EVERYONE must comply with all school parking regulations.

Students and their parents must sign an **Alta High Vehicle Parking Contract** in order to purchase a student parking permit for \$10. Due to insufficient space in the student parking lots, student parking permits will be sold only to 11<sup>th</sup> and 12<sup>th</sup> grade students. **Only one parking permit may be purchased by an eligible student**, however a second permit for motorcycle parking (in the designated motorcycle parking area) is available if needed. All student parking lots are located on the west side of the school nearest the soccer field and tennis courts.

Violations of the Parking Contract may result in one or more of the following consequences:

- 1) Verbal directive to move vehicle to a different location
- 2) A parking citation and fine
- 3) Booting the vehicle
- 4) Towing and impounding at owner's expense
- 5) Parking privileges being revoked for the remainder of the school year

**Students who illegally park in areas not designated for student parking are subject to the consequences above. Student parking citations will be issued for parking in the faculty parking lot (east side of Alta High), the visitor parking lot (PAC lot), the bus drop off area (north side of Alta High), handicap parking spaces where a vehicle ADA permit is not displayed, red curb zones, unauthorized parking in a reserved space that is indicated with signage, or parking in areas not intended for parking such as on sidewalks or lawns. Sandy City Police may also issue their own parking citations for vehicles illegally parked on surrounding streets.**

ALL PARKING CITATIONS MUST BE PAID PROMPTLY. UNPAID PARKING CITATIONS MAY BE SENT TO A COLLECTIONS AGENCY AND/OR PARKING PRIVILEGES MAY BE REVOKED.

**A parking permit does not guarantee an available parking space.** Parking spaces are first come, first served. Students returning from off-site classes may find it difficult to locate a parking space upon returning. This is NOT a valid excuse to park illegally. **Late comers should expect to walk farther to reach the school building.** Vehicles parked on campus without a valid parking decal will be cited.

Vehicles must be moved from the Drivers Ed. Range by 3:00 p.m. to avoid inhibiting Drivers Ed instruction. Violators who inhibit Drivers Ed will be subject to immediate towing at owner's expense.

Completed Parking Contracts are due to the Main Office to purchase a parking decal. All outstanding school fees/fines must be paid to obtain a parking permit. Extenuating circumstances (ex: financial hardship) may be discussed with the school administrator over parking. Parking permits are **not transferable** to another student nor to another vehicle. A damaged parking decal may be replaced without cost by surrendering the previously issued decal to the Main Office.

I understand parking my vehicle at Alta High School is a privilege which can be revoked if I violate this contract and/or school rules and parking regulations. **To retain and maintain my parking privileges I specifically understand the following:**

1. All vehicles must be properly registered and maintained at all times in accordance with state laws.
2. Only eligible 11<sup>th</sup> and 12<sup>th</sup> grade students may purchase a single parking permit. Permit cost is \$10 for the school year. In extenuating circumstances (ex: financial hardship) see the administrator over parking.
3. Student parking permits are sold only in the Main Office. If a student deceitfully purchases a parking permit in behalf of another student, the purchaser and the recipient will be subject to school disciplinary actions.
4. The **parking decal must be visible** and firmly affixed (not taped) to the lower left-hand corner of the front windshield on the driver's side. A vehicle that does not properly display a parking decal can be cited.
5. Students purchasing a parking permit are not guaranteed a parking space. **Late comers should expect to walk a farther distance from their parking space to reach the school building.**
6. Violations of the Parking Contract may result in one or more of the following consequences: a verbal directive to move vehicle to a different location, a parking citation and fine, booting the vehicle, towing and impounding at owner's expense, parking privileges being revoked for the remainder of the school year.
7. **THIS CONTRACT SERVES AS STUDENTS' SOLE WARNING FOR CITATIONS AND FINES DUE TO PARKING VIOLATIONS.** A first citation carries a fine of \$30.00. Each subsequent citation carries a fine of \$40.00. A first boot violation carries a fine of \$50.00. Subsequent boot violations will result in car being towed away at owner's expense. Towing costs and impound fees are determined by the Towing Agency.
8. **ALL PARKING CITATIONS MUST BE PAID PROMPTLY OR THE STUDENT PARKING PASS MAY BE REVOKED.**
9. Students may only park in designated student parking lots. Any student parking in a faculty parking space or in a visitor space or in a signage reserved space is subject to a citation, booting, and/or towing at owner's expense.
10. It is illegal for any vehicle to contain illicit drugs, alcohol, stolen property, etc., while parked on school property or at school activities. Never, under any circumstances, should any type of weapon be in a vehicle while parked at school. Such incidents will be referred for investigation and discipline by law enforcement and disciplinary due process by the Canyons District Case Management Team.
11. School officials have jurisdiction over any vehicle on school property and have the right to search a vehicle, within state and federal laws, and seize improper or illegal materials found in any vehicle on campus.
12. Vehicles must be moved from the Drivers Ed. Range by 3:00 p.m. to avoid inhibiting Drivers Ed classes. Violators who inhibit Drivers Ed will be subject to immediate towing at owner's expense.
13. Students who lose their parking decal will be charged an additional fee to receive a new one. Students who are replacing a windshield or a damaged decal may return the old decal to receive a new one for free.
14. Unpaid parking citations may be sent to a collections agency to obtain payment.
15. **Student must present this signed contract, current vehicle registration, and a copy of his/her driver's license to purchase a parking permit.**

DISCLAIMER: Neither the Canyons School District or the Board of Education will assume any compensatory obligations for theft, lost articles, vandalism, accidents, or personal/property damages while the permitted vehicle or driver is on Alta High School property. Please drive safely, respect all vehicles, and always lock/secure your vehicle.
